SUMMARY ANNUAL REPORT FOR THE PLUMBERS & STEAMFITTERS LOCAL UNION NO. 33 HEALTH AND WELFARE TRUST

This is a summary of the annual report of the Plumbers & Steamfitters Local Union No. 33 Health & Welfare Trust, Employer Identification No. 42-0930021, for January 1, 2023 to December 31, 2023. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

The Plumbers & Steamfitters Local Union No. 33 Health & Welfare Trust has committed itself to pay certain claims incurred under the terms of the plan.

INSURANCE INFORMATION

The plan has a contract with Humana to pay certain retiree claims in excess of medicare coverage incurred under the terms of the plans. The total premiums paid for the plan year ending December 31, 2023 were \$931,993 for Humana coverage.

BASIC FINANCIAL STATEMENTS

The value of plan assets, after subtracting liabilities of the plan, was \$55,530,045 as of December 31, 2023 compared to \$45,575,894 as of December 31, 2022. During the plan year, the plan experienced an increase in its net assets of \$9,954,151. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$31,356,361 including employer contributions of \$22,626,202, employee contributions of \$1,403,659, earnings from investments of \$7,062,592 and other income of \$263,908.

Plan expenses were \$21,402,210. These expenses include \$1,220,310 in administrative expenses and \$20,181,900 in benefits paid to or for participants or beneficiaries.

The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.
